1. Sage West Hospital Update

Alan Daugherty the CEO at Sage West Hospital gave update to council on the hospitals in Fremont County. Serve over 60000 patients a year. Sage West has developed a national quality program with Duke University. Actively recruiting new doctors in different specialties. Sage west employees 357 people in Fremont County. We are very concerned about an active shooter event, June 14th here in Lander to set up an active shooter task force to discuss this concern. Inviting all first responders and representatives from each school to have a panel discussion on it. We want to be ready to be ready if it ever happens. Telehealth care is becoming a focus of Sage West to take health care to the patient in their homes.
