Dr. Firth, representing the Lander Medical Clinic, in asking the City to partner with and LEDA to apply for this program presented to the Council. Dr. Firth discussed the services that they would be offering in a new facility and their plans for a new facility and their hopes for the local health care community.

Dr. Jones, what does it mean that you want to partner with the city what does that mean? We have to partner with the city to be able to apply for this grant.

Dr. Jones have you looked at the data for the community that would show it would support this new recruitment?

Yes we have done the research to see that our community would support these recruitments. Council President Maestas, discussed this process and that the applicant for these funds has to be sponsored by a municipality to apply for this funding. Everyone has this ability to apply for this type of grant with sponsorship of the City of Lander, county commissioners or a joint powers board.

Missy White, what affect does this have on the City?

These are a nonrecourse loan and it would not come back on the city in default.

Rebecca all of the funding for these programs come from the State General fund and all the grants have to be recommend by the business council and then approved by the state lands and investments board.

John Larsen, historically what kind of business council default rate have you had? Rebecca, I don't know of any of them but I can look. The infrastructure would be owned by the community.

Council Member Hahn, if someone defaults on one of these who is the holder of the building? The City would own the property. After 5 years you would be allowed to sell it.

Council President Maestas, the buyout would have to be at a fair market value. It can stay longer with the city than 5 years but it must be at least 5 years.

Mayor would anyone like to speak against this proposal?

Dr. Jones, I think competition is good and I am one of the Lander Medical Clinic's competitors. When a new facility is built I am probably going to be put out of business, and am fine with that in private enterprise. I am not ok with that happening with the partnership of our local government. I don't feel like government should be assisting in that happening, and that they should be picking winners and losers in private enterprise. I think that they should have to go to a bank and request traditional funding.

Jannell Hahn, I worked at the clinic for 41 years. I am very happy that new partners want to expand their clinic but I don't believe that half of that cost should be on the shoulders of the taxpayers. Competition is good for the community and this could cause multiple smaller health care providers around our community to go out of business.

Council Member Hudson, I do believe the Wyoming business council programs were developed for this kind of project.

Council President Maestas, if this was coming out of city general funds I would say no but the pool of money being applied for is set aside specifically for this type of purpose.

Competition has come up many times and I feel like the city needs to set up a system so we can support all qualifying candidates. We are not approving if they get the funding, we are approving if they get to ask for this funding. If you are opposed to it please to Cheyenne and let those boards know.

Melinda Cox, there have been some changes to this program over the last few years. We are working on diverting as many juveniles away from detention centers as we can. We do utilize space at the Fremont County Detention Center until they can be transported to Casper. That happens about 13 times a month. The second thing we do is a day reporting center for kids who have been expelled from school for long period of times. We transport kids to Riverton daily for this program. We have served 214 kids since this program has been opened. We also provide probation services for juveniles. We provide a juvenile treatment court for our high risk populations. We have only requested 12K but in the future that amount is probably going to increase for these

Chief, I agree with everything she said and that they provide a valuable service to our community.
