(a) Personal Privilege – Mayor and Council

John Larsen - Updates from Lander Chamber. Brew fest was a great success. Will be moving it back to the second week in June for next year. 40 plus attend the first young professionals' activity. They have already started their fundraising. Update from LOTRA. They are working on the new lease for the arena. There is lots of interest in LOTRA supplying the cattle for ropings this year. Fire incident command is using the rodeo arena for their command post. Will boost the funds for LOTRA. Update on the event at the airport last weekend. 50 people from the community attended. It was a great event. Fremont County solid waste district update Price has gone up for recycled plastic from \$150 to \$500 a ton. There is also new technology that has improved the recycling of cardboard.

Chris Hulme - No updates from the boards. Appreciate all the work that has been going on with the chip sealing.

Dan Hahn – Thank you for the chip sealing jobs. Asked John about the cost of recycling. If they are breaking even on it. John said he would find out.

Monte Richardson – Update on the 911 Memorial at the firehall on Saturday. Went well. Thanked John Larsen and Chief Peters for participating. Thanked all the first responders for all the work they do. Thanked John Larsen for the help of the incident command setup. The chip sealing looks good. Thanked Lance and his crew for all their work. Melinda Cox - Attended another Senior Center meeting. They had a tailgate themed party today. They are doing a great job with the services they provide in our community. Appreciative to the person who looked at the exhaust pipe. Was asking if that will be replaced. Energy efficient task force board is really good. There are a few things that they are needing from Lance. She attended School District #1 meeting. They

talked about the new signage on Jefferson and 8th Street and the size of the stop signs. They appreciated the Chief talking to them about that. It will take some getting used to. Talked about how important communication is to be able to give the correct information to the community about the different projects that the city is working on.

(b) Staff Discussion Items

Chief Peters – There has been one complaint about the new four way stop at Jefferson and 8th. There is one sign that is smaller than the rest. People are just not used to having it there. The school zones are all changed now to have the lights flashing from 7:30 to 4:30 during school hours. New Code enforcement person will start on Monday. Submitted a grant application to the Bureau of Justice Assistance related to software. It's a 100% grant with no match. It will be for data software systems so we can track a lot better with our mapping and also see where the trends are coming up and any type of crimes or anything going on in the community. Dan asked about lack of housing for the animals that we pick up. Chief said we are still working on that. No one is interested in taking the impounds right now. Still trying to find the right person the right place and the right deal.

Lance Hopkin - FEMA is on sewer pond road. Everything is going good. Streams have changed and had to reassess some things so there will be a change order coming at the next council meeting. Have had a lot of questions about the chip sealing. Contractor will be going back and picking up the extra chips. Hired a new mechanic. Good fit so far. There are six applicants that have applied for the fire/airport position. Will plan to interview in the new few weeks.

RaJean Strube Fossen- Applying for a grant to T Mobile. It would be reimbursement for the funds that you authorized on the purchase of the park land. It would be a \$50,000 grant. Currently getting letters of support. No Match. T-Mobile would want advertising out of it. Update on Maven. They did go through their value engineering process and cut about million and a half out of their project. So, after speaking to the business council, we should be able to award the grant at a lower cost to the low bidder.

Tami Hitshew- Talked about LGLP looking for nominations to fill two board positions.

(h) Authorize Mayor to sign the MOU with Fremont County for Hillcrest Street multimodal study in the amount of \$2,612.50. RaJean Strube Fossen explained the city and the County have been working on this for two years. The county and city are paying 9.15% of the study and our half of the share ends up being \$2,612.50.
